The scope of supply of OMCE-Calculator comprises the following.

- OMCE-Calculator software (with hardware key)

Included in the price is one day technical and software support (by telephone and/or e-mail, not on-site).

Any update of the software released within one year after the date that ECN has received the signed order form will be sent to Licensee free of charge.

The software and documentation are written in English.

Optional: Maintenance

It is possible to order additional maintenance and support. If the additional maintenance is not ordered through this order form, ECN will contact you before the end of the one-year support period to offer you the possibility of a service contract.
